

Terms & Conditions for ASUS Month – Transformers One PC Build Giveaway

General

Information published by the Promoter, as defined below, on how to enter and prizes form part of the Terms and Conditions of Entry ("Terms and Conditions"). Participation into this promotion is deemed acceptance of these Terms and Conditions.

To the extent of any inconsistency between these Terms and Conditions and any other reference to this promotion, these Terms and Conditions prevail.

The Promoter is ASUS Australia Pty Ltd ABN 81148 073 858 ("Promoter") reserves the right to alter the incentive, product offerings and specifications at any time, without notice.

Entry Restrictions

Offer is only open to residents of Australia in eligible states and territories outlined below, and all New Zealand aged 18 or over, as of the date of entry and has fulfilled the requirements set out below. Employees, directors, and contractors and their immediate families, of the Promoter and Promoter's agencies (including but not limited to ASUS retailers and resellers) associated with this promotion are ineligible to enter this promotion.

This offer pertains only to relevant Australian stock sold at participated resellers and is not valid for products purchased from overseas or overseas stock. To be eligible to enter, consumers must purchase one or more of the following participating products from an authorised and participating ASUS retailer/reseller within Australia.

Eligible states and territories in Australia: NSW, ACT, VIC, QLD, WA & TAS (SA, NT not eligible).
