General

Entry Restrictions

Offer is only open to residents of Australia in eligible states and territories outlined below, and all New Zealand aged 18 or over, as of the date of entry and has fulfilled the requirements set out below. Employees, directors, and contractors and their immediate families, of the Promoter and Promoter's agencies (including but not limited to ASUS retailers and resellers) associated with this promotion are ineligible to enter this promotion.

This offer pertains only to relevant Australian stock sold at participated resellers and is not valid for products purchased from overseas or overseas stock. To be eligible to enter, consumers must purchase one or more of the following participating products from an authorised and participating ASUS retailer/reseller within Australia.

Major Prize
